

It is extremely comprehensive and discusses a subject that is truly the foundation of optometry. Ophthalmology colleagues will also find it very useful. Eye doctors who have a grasp of the concepts presented in this book will be able to manage their patients better and set themselves apart from the competition. The book is so nicely laid out and so easy to follow that one of my

colleagues with 30 years of experience helping kids and adults with BV issues actually found joy in reading it for the first time.
