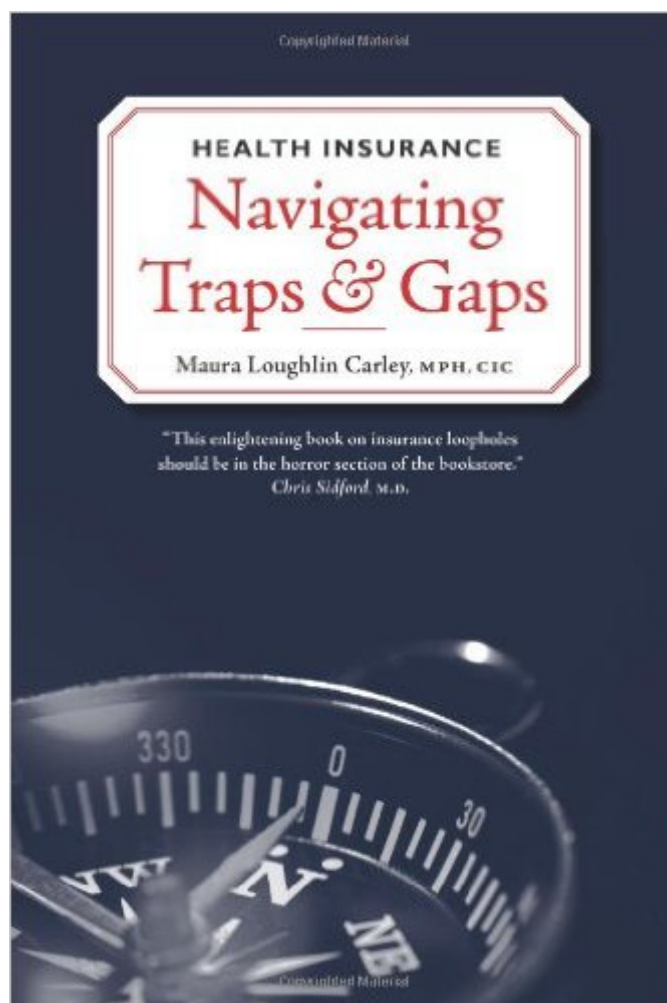

This is such a helpful book! Healthcare is so politicized these days that I couldn't find information I trusted. The author is an expert and doesn't dumb down the information- but she is straightforward and she does use excellent easy to understand examples. As a 24 year old the sections on COBRA, the Affordable Care Act, Turning 26, and Changing Jobs were very helpful. But health insurance is such an obscure and foreign topic that the whole book is useful, especially if you are beginning to deal with sick and aging parents like me- always best to be prepared!
